**Sub: Update on divestment of equity shares – Reg.,**

Refer to our earlier letter no/ BIL/SECT/093/17-18, dated 10.02.2018, wherein we have informed the proposal for divestment of equity shares held in Solar Dynamics Private Limited, Subsidiary Company. In this regard we would like to update you that the equity shares have been transferred to Surana Infocom Private Limited on 21.03.2018. The following are the details to be disclosed as specified in Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015:

The revenue from the Subsidiary Company viz., Solar Dynamics Pvt Ltd is Rs. 4,60,33,235 which contributes 1.55% of total revenue of Bhagyanagar India Limited as well the net worth is Rs. 3,08,92,165 which contributes 2.98% of total net worth of Bhagyanagar India Limited during the last financial year 2016-17.
- b) **Date on which the agreement for sale has been entered into;**  
10<sup>th</sup> February, 2018
- c) **The expected date of completion of sale/disposal;**  
The transfer of equity shares completed on 21.03.2018.
- d) **Consideration received from such sale/disposal;**  
The consideration received from sale of equity shares is Rs.1,30,41,300/- (13,04,130 equity shares at face value of Rs.10 each).
- e) **Brief details of buyers and whether any of the buyers belong to the promoter/ promoter group/ group companies. If yes, details thereof;**  
Surana Infocom Private Limited, transferee is a Promoter/ Promoter Group Company which acquired shares of Solar Dynamics Private Limited.

The transaction would fall under related party transaction. However the same has been done at arm's length basis.


